From 95 North: Take 95 south to exit 1B (896 north, Newark) in Delaware. Follow 896 North through Newark (this road makes a few turns, please watch signs closely). Follow 896 North into Pennsylvania and continue to the second stop sign (go through the town of Kemblesville and into New London). At the stop sign continue on Rt 896 to the next Rd on the left, Oxford RD. Turn left onto Oxford Rd and continue 1.7 mile to Elkdale Rd on the right. Turn right onto Elkdale. Trial site is the first driveway on the left.

From 95 South: Take 95 North to exit 100 in Maryland (Rt 272) Stay on 272 into PA. Rt 272 will turn left at "Jim's Market" stay straight onto Barnsley Rd. Stay on Barnsley Rd into Oxford PA, turn right onto Rt 472 to Oxford Rd on the left. Turn left onto Oxford Rd go 2.9 miles to Elkdale Rd on the left. Trial site is the first driveway on the left.

From RT 1 North or South: Take the 869 (Russellville/New London) eixt. Go south toward New London. At the stop sign merge onto Rt 796 south. Look for Oxford Rd on the right. Turn right onto Oxford Rd, go 1.7 miles to Elkdale rd on the right. Turn right onto Elkdale. Trial site is the first driveway on the left

GENERAL INFORMATION

The correct money amount must accompany your entry form(s). Any Checks returned will be considered a void entry. There is a \$45 service charge for all returned checks. If entries are resubmitted fees must be paid in money order or cashiers check.

Entry fees will not be refunded is the show cannot open or be completed by reasons or riots, civil disturbance, fire and/or weather conditions, acts of God, public emergencies, acts of public enemy, strikes, or other causes beyond the control of Fly Away Field

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or judge, or banned from competition by the Trial Committee or Course Director.

Running order will be drawn the morning of each Trial.
PLEASE USE ONE FORM PER DOG. NO REFUNDS

In the case of a dog injuring stock, dog's owner will pay all vet fees and/or replacement value of the stock (Sheep \$300, Ducks \$40) and/or any veterinary or disposal fees if required.

Each owner/handler is responsible for their dog(s). All dogs must be confined or on lead except when competing. Dogs are not allowed to run loose during the trial or after the trial without permission from the Course Director. There is a pond where people with permission will be allowed to swim their dogs and themselves.
